- 5. Failure to comply with these conditions may result in the withholding of your invoice payment.
- 6. This order is executed in Orange County, California, and is subject to local jurisdiction.
- 7. Personnel Qualifications- The supplier's Quality System shall assure all relevant Purchase Order requirements are met and all applicable processes affecting the final quality of the product in the Purchase Order were rendered by qualified personnel. NDT personnel shall be certified IAW NAS410
- 8. Quality System- Vendor shall maintain a quality and inspection system which is compliant with the requirements of ISO9001 / AS9100 and all other terms of this Purchase Order manufacture and or delivery of the materials or services stated within this order.
- 9. Calibration system compliance to ISO/IEC 17025, ISO10012-1, AS9100, ANZI Z540.1/.3 (MIL-STD-45662) or equivalent is required.
- 10. Raw Materials- Shall be domestic or DFARS252.225-7014 compliant.
- 11. HUB Metals and Trading, Inc. and its customers, reserve the Right of Entry to inspect the supplier's facilities and processes for the adherence to purchase order requirements.
